

Mobilising the energy of the territories

In 2022, the EDF Group Foundation contributed in its own way to supporting civil society initiatives in response to a multicrisis context.

First of all, the international crisis, with the war in Ukraine, on Europe's doorstep, which led us to launch emergency support to accompany civilians and families from the first hours of the conflict, and then to support in the months that followed a training project for Ukrainian refugees wishing to settle in France.

The environmental crisis, with increasing pressure on resources and the already visible effects of global warming. It is now time to adapt with the projects we support for nature-based solutions such as those supported by IUCN in Indonesia for the planting of mangroves or the reforestation of the Maubuisson forest in Île-de-France. Each of these experiments aims to reconcile the preservation of biodiversity and adaptation to climate change.

The social crisis, with strong expectations from territories to support the inclusion of young people and accompany the most disadvantaged. The Second Chance Schools, spread throughout the country, are an emblematic example of our ambition to participate in building a more inclusive society.

In this world that needs to be reinvented, the key issue is not to oppose the environmental and social causes but to articulate them. Like the «BE» schools


that we support to enable young people to become professionally integrated by orienting themselves towards the jobs of the ecological transition.

Our actions focus on providing financial support and committing to promoting the know-how of our employees. Their skills are useful for the general interest: internationally to electrify schools or health centres using renewable energy; in France, with our employees involved in mentoring and whose experience is key to supporting young people in their choices, facilitating the discovery of the professional world and socio-cultural openness.

Our Foundation embodies the company's raison d'être, which aims to combine environmental virtue, wellbeing and development. The equation cannot be solved without including the principle of solidarity and experimentation. This is our role: to finance, support, document and disseminate the diversity of initiatives of high social and environmental value that are emerging everywhere in the territories, led by citizens' collectives linked together within the associative fabric. We believe in the power of experimentation: these actions are prototypes, catalysts for wider changes that open up the field of possibilities for creating new imaginaries.

Increasing support for innovative local initiatives

2022 has seen a further intensification of monitoring in the territories, in order to identify innovative initiatives as they emerge. In France, in the metropolitan and overseas regions, calls for proposals have multiplied in our three fields of action to extend and consolidate the network of associations and NGOs supported by the Foundation. Internationally, the projects supported by our employees through skills patronage have provided access to essential goods for many beneficiaries.

During the year, two events changed the composition of our Board of Directors: the appointment of Luc Rémont as Chairman and CEO of the EDF Group and as Chairman of our Foundation, and the evolution of our founding members with the merger of Dalkia and Citelum.



Structures and skills

The Foundation's governance is the guarantee of autonomy, of representativeness and of the orientation of its action in favour of general interest. It is structured around five decision-making bodies. The Board of directors, the selection committee, the France territorial committee and the international territorial committee concern the sponsorship of projects. Their competence is defined according to the amount of support granted to the associations and the location of the projects. The culture committee rules on the cultural programme and exhibitions.

Sustainable values

The Foundation respects the fundamental principles and rights enshrined in the Universal Declaration of Human Rights, the United Nations Global Compact and the United Nations Convention against Corruption by applying a rigorous ethical policy. Monitoring the integrity of its partners and of the associations it supports, it contributes to the prevention of fraud and corruption.






